Next Steps:

Creation of a Logic Model of Implementation and Operation of Keystone STARS

Before delving into revising Keystone STARS, the Think Tank convened in September to develop a shared understanding of the outcomes we want to achieve in the short-, medium- and long-term. A well-articulated logic model will specify the activities, linkages, and partnerships expected to support shared desired outcomes.

Identify the Structure to meet desired outcomes

Since the current structure was created 14 years ago, dozens of states have developed and tested new models. Based on other states' experiences, the Hybrid Model may best fit Pennsylvania's needs. At lower levels of ratings, all indicators in all standards must be met. At higher levels of ratings, points are assigned to standards and programs have the flexibility of choosing where to put their emphasis in earning points. The Think Tank will review and evaluate how the Hybrid Model could work best for Pennsylvania.
