Your renewal observation window may be scheduled up to six months prior to the expiration of your current observation scores.

In addition to assessments for monitoring and movement, there are several events that require a full assessment. These include if a program's ERS or CLASS score expires while the program does not hold a full DHS Certificate of Compliance, 50% staff turnover since the program's last annual review, or significant program growth (program adds a new age group).
