



Keystone STARS Grant & Award Structure Overview FY 13 -14

Keystone STARS encourages and supports programs to develop and sustain higher levels of quality in order to strengthen outcomes for children and families and to improve school readiness. The SUPPORT GRANTS and MERIT AWARDS charts below indicate the maximum resources available, with approved expenses and submitted receipts, to qualifying programs at varying Keystone STAR levels, based on Full Time Equivalency (FTE). Family Child Care Home facilities eligibility could also be established by being enrolled in TIER 1 Child/Adult Care Food Program (CACFP) – administered through the United States Department of Agriculture (USDA).

Eligibility for grants and awards requires serving a subsidized population of no less than 10%.
